Term and Conditions:

- 1. Resident from respective District / Tehsil as per CNIC/Domicile will be allowed for test against one location only.
- 2. Interested candidates must bring original documents i.e. Personal, Educational & Professional for test as per specified time. Requests for consideration after lapse of time will not be entertained.
- 3. Only shortlisted candidates after qualifying test shall be called for interview.
- 4. Employees serving in Government/Semi-Government departments must provide No Objection Certificate (NOC) at the time of interview.
- 5. Attested degrees/certificates from Higher Education Commission (HEC)/respective educational boards must be provided at the time of interview.
- 6. Selected candidate will be hired on contract for a period 5x years including 6x months' probation period.
- 7. Selected candidate shall provide Medical Fitness and Character Certificates.
- 8. Appointment is being made against a specific NADRA Registration Centre (NRC); therefore, no request for transfer shall be entertained.
- 9. 05 years age relaxation is already included in above age limit.
- 10. Electronic gadgets such as mobile phone, smart watch etc. will not be allowed during test /interview.
- 11. No TA/DA will be admissible for Test & Interview.
- 12. Females, Minority, Transgenders and Differently-abled candidates are encouraged to apply.
